MEMORANDUM OF UNDERSTANDING (MoU)

Between **Kapila Charitable Trust** and **Gavyasidha Partnership Firm**

Regarding the **Maintenance of Kapila Goshala**

This Memorandum of Understanding (MoU) is entered into on this **02 day of, May 2025**,

BY AND BETWEEN:

Kapila Charitable Trust,

a public charitable trust, registered under the relevant laws, having its office at **H.No: 9-7/4, Swarnapalle, Manthani, Peddapalli District, Telangana**, hereinafter referred to as "Trust", which expression shall, unless repugnant to the context or meaning thereof, mean and include its trustees, successors and permitted assigns;

AND

Gavyasidha Partnership Firm,

a registered partnership firm under the Indian Partnership Act, 1932, having its principal place of business at **#38, P & T Colony, Opp to RTA office, Trimulgherry - 500015, Secunderabad, Telangana**, hereinafter referred to as "Firm", which expression shall, unless repugnant to the context or meaning thereof, mean and include its partners,

successors and permitted assigns;

Collectively referred to as the "Parties" and individually as a "Party."

1. PURPOSE

The purpose of this MoU is to outline the collaborative framework between the Trust and the Firm for the maintenance, development, and daily operations of **Kapila Goshala** situated at **#2-103/1, Battupalli, Manthani, Peddapalli District, Telangana**, and to govern the use of a jointly operated bank account to manage funds related to the Goshala.

2. SCOPE OF RESPONSIBILITIES

2.1 Trust Responsibilities

- Maintain ownership and oversight of Kapila Goshala and its associated properties.
- Provide governance, approvals for developmental activities, and periodic reviews.
- Collaborate in fundraising and ensure compliance with legal and charitable obligations.

2.2 Firm Responsibilities

- Handle daily care of cows, staff management, and logistics.
- Maintain cleanliness, health, and ethical management of the Goshala.
- Assist with financial tracking, donor communication, and event coordination.

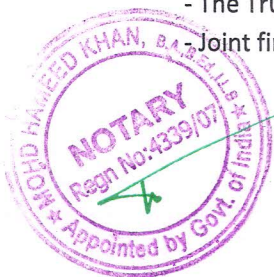
3. JOINT BANK ACCOUNT

A joint bank account shall be opened and operated in the name of "Kapila Goshala - Joint Operations Account". The account shall be jointly managed by one authorized representative from the Trust and one from the Firm.

- All donations, contributions, and funds related to Goshala operations shall be deposited into this account.
- Withdrawals and disbursements shall require dual signatures and proper documentation.
- The Parties agree to maintain transparency, mutual consent, and detailed records of all transactions.

4. FINANCIAL ARRANGEMENTS

- The Firm shall submit monthly expense reports for reimbursement or verification.
- The Trust shall allocate funds for approved activities and emergency expenses.
- Joint financial audits may be conducted periodically.

5. TERM & TERMINATION

- This MoU shall be valid for a period of 3 (three) years from the date of execution and may be extended by mutual consent.
- Either Party may terminate the MoU with 30 days' written notice citing reasons.
- Upon termination, the joint bank account shall be closed after settlement of all obligations and balance funds shall be distributed as mutually agreed.

6. DISPUTE RESOLUTION

Any disputes arising out of or in relation to this MoU shall first be resolved amicably. If unresolved, disputes shall be referred to arbitration under the Arbitration and Conciliation Act, 1996. The arbitration shall be held in Secunderabad.

7. MISCELLANEOUS

- This MoU shall not create a legal partnership or employment relationship.
- Amendments must be in writing and signed by both Parties.
- Both Parties commit to lawful, ethical, and transparent operations.

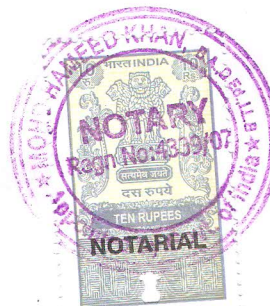
