

And Whereas the Trustees named above are willing to accept the office of the Trustees for the purpose of carrying out the wishes of the Settlor of the Trust under the provisions and directions set forth herein, so as to enable to pursue its vowed objects.

NOW THIS DEED OF DECLARATION OF TRUST WITNESSES AND DECLARES AS UNDER:

1. Name:

The name of the Trust shall be "KAPILA CHARITABLE TRUST"

2. Place:

The office of the Trust shall be at H.No. 9-7/4, Swarnapalle, Manthani, Peddapalli Dist. for the present and at any place or places as may be mutually agreed upon by the Trustees from time to time.

3. Board of Trustees:

The Trustees named above shall be the Board of trustees and have given their consent to be appointed as the trustees and as token thereof, they have set their hands to this instrument.

4. Settlement:

The Settlor of the Trust hereby has set apart a sum of Rs. 10,116/- (Rupees Ten Thousand one hundred and sixteen only) to be held in Trust as nucleus for the purpose of the Trust and handed over the same to the Trustees.

5. Objectives of the trust:

Gaushalas

- a) To establish and run Gau-shalas for the protection of cows.
- b) To provide Foods, Shelters and medical facilities to cows and develop and grow grass and plants in open lands for providing food to the cows which are considered sacred and worshipped since ancient times in our Sanathana Dharma.
- c) To Prevent Slaughter of cows, calves and bovine cattle and to receive and maintain bovine animals offered by public.
- d) To provide medical aid, treatment and a last resort/ shelters to Cows having got maltreatment/ not handled properly due to any reason and to conduct veterinary health camps in villages located far away from the livestock units, to treat cattle suffering from diseases and extend medical and surgical treatment to the sick animals, free of cost and to vaccinate the cattle against common contagious diseases.


- e) To provide ayurvedic treatment and medicines made from Panchagavya (Cow milk, ghee, yogurt, cow dung, urine) for treatment of various diseases like cancer etc.
- f) To encourage organic farming i.e to use Cow dung and urine as a manure and fertilizer for carrying out agricultural activities.
- g) To conduct training camps and programmes in rural areas to help rural poor understand the ways and means of maintaining their cattle properly, protecting them from diseases and to improve milk yield.

Gurukulams

- h) To establish and run gurukulams for providing education, food and shelter to poor and needy students.
- i) To develop them in all aspects physically and mentally by way of yoga, sports, career development opportunities, motivation programmes etc.
- j) To provide grants, scholarships and other forms of financial assistance to the needy and deserving students for pursuing education, vocational training, skill development etc.

Other Objects:

- k) To establish, maintain or grant aid for the establishment and / or maintenance of parks, gardens for the public at large.
- l) To give donations in cash or in kind or any other kind of help to other charitable trust having similar objects.
- m) To do other public welfare programmes.
- n) And to carry out any other activities, events to achieve above said objects.
- o) To acquire movable and immovable properties in the name of Trust and manage them properly for achieving the objects of the trust.
- p) The Trust will not carry out any activities with the intention of earning profit and will perform with service motto.
- q) No activities of the Trust will be carried out outside India
- r) The above objects are independent of each other and the Board of Trustees constituted for the time being, shall apply the funds of the Trust in carrying out all or any of the aforesaid objects of the Trust.

6. Trust Assets :

The Trustees do hereby agree that they shall hold and stand possessed of the said Trust assets, properties and funds (which expression shall include all investments in cash or kind or in any nature whatsoever into and for which, the said property or a part or parts thereof may from time to time be converted, varied or exchanged) and/ or such investments as may be held by the Trustees from time to time in relation to these presents together with all income, profits, additions and accretions thereof, upon Trust for the object set out herein with and subject to the provisions and conditions hereinafter contained in these presents.

7. Beneficiaries of Trust:

The Trust is established for the benefit of all without any distinction and discrimination.

8. Number of Trustees:

A. Founder Trustees:

- a) The affairs of the Trust shall be managed by a Board of Trustees consisting of not less than two and not more than seven members.
- b) In case of any vacancy arising due to death or incapacity/ unsound mind, the remaining Trustees by mutual consent admit his legal heir who is major to act as trustee.
- c) The term of office of Founder Trustees shall be for their respective lives. The Board of Trustees shall have the power to increase the total number of Trustees upto the maximum number stated in 8B(a) below.

B. Membership :

- a) The founder trustees shall have sole discretion either to admit or to reject the application for admission of members without assigning any reason. On rejection of application, the fees if any, collected shall be refunded. However the total number of members including founder trustees shall not exceed Twenty Five (25).
- b) The legal heirs of members other than founder trustees do not have any right to become trustee by inheritance.

- c) The opinion of the members so admitted shall be advisory and not binding on the founder trustees. Such member shall be a scholar and person of eminence in any field or faculty and whose services are very much essential and required for achieving the objectives of the Trust.

9. Chairman of the Trust:

- a) The Settlor of Trust shall act as Chairman of the board and he will hold office for his life time.
- b) In the event of any vacancy in the office of Chairman, the remaining trustees shall elect one of the other Trustees as Chairman for the meeting.

10. Meetings of the Trust:

- a) The meetings of the Trustees shall be presided over by the Chairman of the Trust and in his absence the Trustees present in the meeting shall elect one of them to preside over that meeting.
- b) Seven days notice of all meetings of the Trustees shall be given to all Trustees either by Registered Post or in any other manner as decided by the Trustees.
- c) All decisions shall be carried out by the majority decision of the Board but in the event of equality of votes, the Chairman presiding over the meeting shall have a casting vote.
- d) Any resolution in writing signed by all the Trustees by circulation shall have equal force as though it has been passed at a meeting of the Board of Trustees.
- e) The General Body meeting of the Trust shall be convened once in a year by the secretary, in the month of April for approving the annual accounts and to take approval of annual budget and performance of the trust. The board shall meet atleast once in a quarter.
- f) The proceedings of the Board of Trustees shall not in any way be invalidated due to any post or posts remaining vacant. During the time when a vacancy is yet to be filled up, the remaining Trustees shall act as "Full Board", subject to the presence of Quorum in the meetings. Any vacancy in the Board of Trustees or illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board.

11. Quorum of the meeting:


- a) The quorum for the meeting shall be two or one-third of the total number of Trustees, whichever is higher.
- b) In case there is no quorum at the time fixed for the meeting, the meeting shall stand adjourned by half an hour and the Trustees present at the adjourned meeting shall form the quorum. The postponed meeting is entitled to transact its business without waiting for the quorum, but it shall not undertake any matter for consideration which is not announced in the agenda of regular meeting.

12. Irrevocable:

The Trust hereby created is not revocable at the instance of the Settlor of the Trust at any time and under any circumstances.

13. Powers of Board of Trustees:

- a) To receive any monies and further assets in any shape or form as and when given by the Settlor of the Trust, any of the Trustees or any other persons or institutions or Government.
- b) To collect funds by donations, subscriptions, grants, presents or contributions.
- c) To invest the funds to the extent necessary in accordance with the provisions of section 11(5) of the Income Tax Act 1961 as amended from time to time so that the Income of the Trust will be exempt from Income Tax.
- d) To acquire on lease, purchase, or otherwise, sell, mortgage, lease out or transfer in any other manner properties (movable or immovable), construct buildings and effect other improvements for the purpose of the Trust.
- e) To borrow from banks, financial institutions or any individuals for the purposes of the Trust and also on personal credit of the Trustees with or without charges or responsibility upon the assets of the Trust.
- f) To meet necessary expenses to be incurred in connection with the execution and administration of the Trust.
- g) To establish centers in different parts of the country for carrying out the objects of the Trust.





- h) All bank accounts shall be operated with any scheduled bank permitted U/s 11(5) of the Income Tax Act, 1961 by the Chairman of the Trust.
- i) The trustees may carry out any activity which is not illegal for the benefit and for achieving the objects of the trust.
- j) The trustees shall continue the charitable activities taken up by the settler before establishment of the trust and to complete the same.
- k) The Trustees, if they so choose and for the benefit of the Trust may delegate by means of a resolution in writing any or all of their powers to any one or more of them or any other person for such time and purpose as they deem fit.
- l) To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the Trust.
- m) The trustee(s) shall be responsible only for such activities done by Themself(ves). They shall not be responsible for the negligence or default or fraud committed by other trustees
- n) The Board shall have power to make and rescind rules and regulations for the management and administration of the Trust.
- o) The Board of Trustees will follow the instructions given by any donor who makes substantial contribution towards furtherance of the objects of the Trust, so long as such instructions are not detrimental to the attainment of the objects of the Trust and are in conformity with the provisions of the Income-tax Act, 1961.
- p) To do all or any of the aforesaid things, transactions or matters and do all such other things as are incidental to the attainment of the aims and objects of the Trust.
- q) The Board of trustees shall have the power to remove any member suffering from physical or mental disability or if he is accused of misfeasance of Trust funds or property or misconduct or failed to comply with the rules and regulations of the trust, after satisfying himself on enquiry and such action of the Board shall be final.

- r) None of the powers enumerated above will be deemed to authorise the carrying on of any activity for profit by the Trustees and these powers shall be exercised by the Trustees in such manner that the income of the Trust will be totally exempt from tax under sections 11, 12 and 13 of the Income Tax Act, 1961 or such other sections or clauses as amended from time to time.

14. Roles & Responsibilities of Board of Trustees:

a) Chairman:

- i. The Chairman is authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, Government Institutions and other organizations, on behalf of the Board of Trustees.
- ii. The Chairman shall have all the residuary powers, not explicitly assigned to any of the other officers in these presents.
- iii. The Chairman is responsible for ensuring that the Trust pursues its Objects and for maintaining the dignity of the Trust organization and shall use his influence to promote the activities of the Trust.

b) Secretary:

- i. The Secretary shall maintain the records of the organization prepare and circulate agenda and minutes of Board of Trustee meeting for the approval of the Chairman.
- ii. He is responsible for the safe custody of all the properties and records of the Trust.
- iii. The Secretary shall represent the Trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the Trust in Government offices.
- iv. The Secretary shall deal with correspondence received by the Trust, send replies in consultation with the Chairman, and/or the Treasurer where necessary.

c) Treasurer:

- i. The Treasurer is authorized to sign bank cheques, application for drafts and payment instructions and draw money from the bank, upto the limits defined by the Board of Trustees in their meetings.
- ii. The Treasurer is responsible for safe custody of cash, bonds, securities etc. of the Trust.

- iii. The Treasurer is responsible to prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval.

d) Trustees:

- i. The trustees shall attend the meetings of the trust.
- ii. They shall jointly make decisions for promotion of objects of the Trust by majority opinion.
- iii. The Trustees shall hold honorary office and shall not be entitled to any Salary, allowances or perquisites, except for the reimbursement of actual expenses incurred in attending the meetings and in connection with carrying out the objects of the Trust.

15. Disqualifications of the Trustees:

The trustee who

- i. is Convicted or
- ii. has become insolvent or
- iii. is indulged in criminal case or
- iv. has denounced Sanathana dharma

is ineligible to continue as trustee and his trusteeship will be cancelled.

16. Retire from Trusteeship:

Any Trustee, including the Chairman may retire from the Trusteeship hereof by giving two calendar months notice in writing of his or her intention to do so, to the Board of Trustees and after the expiry of the period of notice, the Trustee giving the notice shall ipso facto cease to be a Trustee of these presents.

17. Accounts:

- a) The Trustees shall cause true and correct accounts to be kept of the sums of money and other assets received and expended on behalf of the trust.
- b) The trustees may appoint an accountant having required qualification for the preparation and maintenance of books of accounts of the trust.
- c) The financial year of the Trust shall be from 1st April to 31st March of the following year.

- d) The financial statements shall be signed by the Chairman, Secretary and Treasurer of the Trust.

18. Audit:

- a) Once at least in every year, the accounts of the Trust shall be audited for their correctness by a Chartered Accountant appointed by the Trustees.
- b) The Chartered Accountant so appointed shall submit audit report in Form 10B or any other form as prescribed and to file return of income within the time specified as per income Tax Act, 1961.

19. Application of Funds:

The funds and income of the Trust shall be solely utilized towards the achievement of the objects and no portion of it shall be utilized for payment to Trustees by way of profit, dividend etc.

20. Amendments:


The rules governing the administration of the Trust may be amended by the Trustees with the permission of the Commissioner of Income Tax, so however; that the amended rules are not inconsistent with the object of the Trust and are not repugnant to the provisions of Sections 2(15), 11, 12 and 13 of the Income Tax Act, 1961, or such other sections or clauses as may be amended or added from time to time governing the activities of Public Charitable Trusts.

21. Dissolution or Winding up:

In the event of the dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees but the same shall be transferred to another charitable trust, society, association or institution whose objects are similar to those of this Trust and which enjoys recognition under section 12A of the Income Tax Act, 1961.

22. Applicability of Trust Act:

The provisions of the Indian Trust Act 1882 shall apply to all matters not specifically mentioned in these presents.
